INVITATION TO BID *(Revised)*

Date: August 9, 2021 *(Revised September 9, 2021)*

Sealed Bids will be received by Greenville Utilities Commission (Owner) at the Wastewater Treatment Plant, 240 Aqua Ln, North Carolina, 27834 until 2:00 p.m., local time, Thursday, September 23, 2021 for the WWTP Headworks Facility Improvements project.

At said place and time, and promptly thereafter, all Bids that have been duly received will be publicly opened and read aloud.

The proposed Work is generally described as follows:

Base Bid

- Modifications to existing Headworks Facility consisting of the following:
  - Structural rehabilitation consisting of concrete surface repairs and corrosion protection lining of existing interior channels, flumes, tanks; and rehabilitation or replacement of existing metal access covers and supports.
  - Odor control piping modifications.
  - Demolition of existing and installation of new Eutek Headcell in Grit Tank No. 1.
  - Modifications to existing slide gates.
  - Electrical systems rehabilitation consisting of replacement of corroded light poles, fixtures, receptacles, and raceways.
  - Replacement of Electrical Room exterior personnel door and exhaust fan.
- Structural rehabilitation of existing Drain Pumping Station consisting of concrete surface repairs and corrosion protection lining.
- Miscellaneous sitework including demolition, pavement modifications, and yard piping.
- New Headworks Facility permanent bypass main.

Alternative Bid Items

- Temporary Bypass Deductive Alternative.
- 48-inch Plug Valve Deductive Alternative.

Contractor and all Subcontractors will be required to conform to the labor standards and employment requirement set forth in the Contract Documents.

If the Contract is to be awarded, Owner will give the Successful Bidder a Notice of Award within the number of days set forth in the Bid Form for acceptance of the Bid.
