ELECTRIC RIDER RR-3

BILATERAL METERING FOR SOLAR ENERGY FACILITIES

CREDIT RIDER (PV)

I. AVAILABILITY

This Rider is available in conjunction with the Commission’s Rate Schedule ER-1, Residential Service; Rate Schedule EG-1, Small General Service; and Rate Schedule EG-2, Medium General Service for customers who operate a solar photovoltaic generator without battery storage, located at the Customer’s primary residence or business.

The rated capacity of the generating system shall not exceed 20 kW for a residential system or 500 kW for a non-residential system. The generating system that is connected in parallel operation with service from the Commission and located on the Customer’s premises must be manufactured, installed, and operated in accordance with governmental and industry standards, and must fully conform with the Commission’s Interconnection Procedures, Forms, And Agreements.

C. Energy Credit:

The associated energy rate credit will automatically adjust to track changes in the demand and energy rates charged the Commission by NCEMPA. In no event will energy delivered to the Commission be credited in a different billing period or different season.

For interconnected systems approved prior to August 1, 2015, the Customer shall receive credit for all energy delivered in kWh to the Commission during the current month.

For interconnected systems approved on or after August 1, 2015, whether new or additional capacity to previously approved systems, the Customer shall receive credit for all energy in kWh delivered to the Commission up to the level of energy consumed in kWh by the Customer during the current month. In no event shall the Customer receive credit for energy delivered to the Commission in excess of the energy delivered to the Customer during the current month.

III. CONDITIONS

1. This Rider is applicable to all electric service of the same available type supplied to the Customer's premises at one point of delivery
2. The Customer must complete an interconnection request application and submit to the Commission for approval prior to receiving service under this Rider.
3. The Customer's service shall be metered with two (2) electric meters. One measures all energy provided by the Commission and consumed by the Customer. The other measures the amount of energy generated by the Customer's solar generator.
4. In the event the Commission determines that it is necessary to install a dedicated transformer or other equipment to protect the safety and adequacy of the electric service provided to other Customers, the Customer shall pay the greater of a monthly facility charge totaling \$25.00, or 2% of the total installed cost of the additional facilities.
5. The Commission reserves the right to test the Customer's solar generator for compliance with the applicable interface criteria. Should it be determined that the Customer's installation is in violation of these criteria the Commission will disconnect the solar generator from the Commission's distribution system and it will remain disconnected until the installation is brought back into compliance.

IV. TERM OF CONTRACT

The term of contract for service under this Rider shall be as mutually agreed upon, but not less than one (1) year, and thereafter shall be renewed for successive one year periods. After the initial period, Customer may terminate service under this Rider by giving at least sixty (60) days previous notice of such termination in writing to the Commission.

The Commission reserves the right to terminate service under this Rider at any time upon written notice to Customer in the event that Customer violates any terms or conditions of this Rider, or operates the generating system in a manner that is detrimental to the Commission or its customers.
